The Front-Line ... Because You Care by Hulen E. Bivins, Executive Director

With the beginning of a new calendar year, public librarians are continuing on their serendipitous journey that has been caused by the COVID virus and the multiple variants associated with the health disease. This unplanned journey has taken some interesting turns as it has not necessarily been an "action equals results" circumstance. Indeed, because of the health concerns of the past months, librarians are now "front-line workers" in the fight being waged against a health concern that does not diminish.

Obviously, health care workers are front-line workers serving in hospitals and clinics across our state and our nation. At the same time, librarians are providing privacy to individuals in public library facilities so they might have medical consultations about serious health concerns with medical professionals. Further, librarians acting as front-line workers have made themselves available as volunteers to help the citizenry to use library computers to master the use of TeleMed services. Beyond these key services, librarians are also helping library users to file medical claims with insurers.

Imperative for some households are the computer services offered at the public library that aid in the virtual learning processes now prevalent in both public and private schools as well as the schools of higher learning. In this work, the local public library provides connectivity to the databases of the MAGNOLIA collection and assistance to the student doing information research. Much of this work is being accomplished in the void created by the lack of in-person schooling and the lack of in-person contact with the school library that has been shuttered in the closed school building.

Other taskings wherein public librarians are being called upon as front-line workers is a role aiding the development of small business, especially in legal requirements such as taxation rates and how-to information for appropriate and timely tax filings. Just recently, the Internal Revenue Service (IRS) has instituted rules that require certain segments of the population to provide a video selfie to access their IRS accounts. Few places in any community will offer these video recording services.



It will be public librarians, working as front-line workers, that will be there to help in this requirement.

The few tasks enumerated illustrate the importance of public librarians and these actions are all in addition to the services provided for many decades to many segments of the citizenry. Continuing services provided by public libraries include the offering of intellectual, cultural, and educational materials in multiple formats that advances the quality of life in any community.

During your next visit to your local public library, you might want to thank the library staff for what they are doing for the community as front-line workers as their actions maintain a cultural identity amid the socioeconomic complexity of the day.




## Waynesboro-Wayne County Library Distributes Shoes for the Holidays

# Kemper County Celebrates 10 Years of the Dolly Parton Imagination Project (DPIP)



### U.S. CENSUS / IMLS DATA REPORT

The Census has developed, working with the Institute of Museum and Library Services (IMLS), a dashboard comparison of each state's FY19 Public Library Annual Report data with the 2015–2019 American Community Survey Data. Interacting with the layers, users can discern the public library building location and statistics at the county level. Scrolling through the panels on the sides allows for a view of statistics for each state. The information provided also allows a view of all the library systems within a state and provides a link to imls.gov to access downloadable PDFs.




